Welcome to the community newsletter from McGee. We are carrying out the demolition and façade retention phase for the North and South blocks as part of the South Molton development, on behalf of Grosvenor and Mitsui Fudosan.

Progress so far.

- 56 Davies Street Portland stone façade deconstruction and demolition works complete to level 1.
- 48-58 Brook Street demolition is nearing completion.
- Piling works are ongoing.
- Façade retention structure has been installed to 52-54 Davies Street.
- Hoarding graphics have been installed.
- Underpinning works have commenced to the site perimeter.
- Reinforced concrete works have commenced to Davies Mews.

- Piling to the south basement will continue for the next month and is due to be complete in early August.

- Small diameter piling to the North building on Davies Street.

Dear Neighbours,

Please see the progress Curo have made over the past month and works we are planning to commence during the month of July.

Works to date:

- Groundwork underpinning to 15 and 16 SMS are advancing as planned with 70 out of the 98 underpins completed so far.
- Hoarding and graphics installation outside 15-25 SMS is now complete.
 Noise, dust and vibration monitoring has been installed on both South Molton Lane and South Molton Street.



Forthcoming works:

- Structural demolition works in 15 and 16 SMS will commence this month following completion of underpinning works.
- Investigative works are ongoing to uncover and protect heritage features within the scheme and protect Georgian features such as stoves and staircases.




Noise, dust and vibration monitoring

We have recently installed noise, dust and vibration monitoring systems along the site hoarding on South Molton Street and South Molton Lane. This allows us to track the noise, dust and vibration generated by our works to ensure we do not exceed the agreed limits set to minimise impact on the public and local community.



<u>Underpinning</u>

Underpinning is a method used to make the foundations of an existing building stronger. This involves adding deeper supports made of concrete. These supports are installed one at a time to make sure the building remains stable. On South Molton Street, underpinning is being done to enlarge the basement, making it more useful and spacious to future occupiers.
